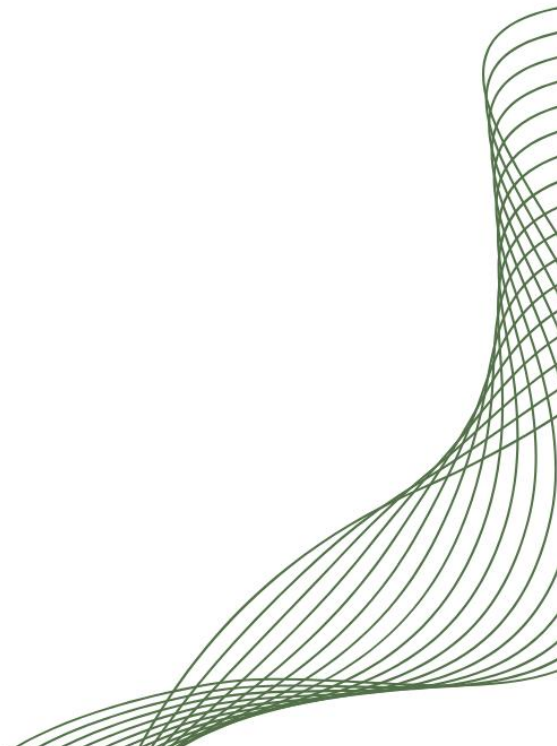

This policy outlines our commitment to promoting sustainability across our school community.





Purpose and Aim

- To establish a clear strategy dedicated to promoting sustainability within our school.
- To ensure all stakeholders are aware of and engaged with our sustainability initiatives.
- To equip students and staff with the knowledge and skills necessary for responsible resource management and environmental stewardship.
- To actively monitor and evaluate our progress in implementing our sustainability strategy.
- To foster a culture of continuous improvement in sustainability practices and environmental wellbeing.



Sustainability Strategy

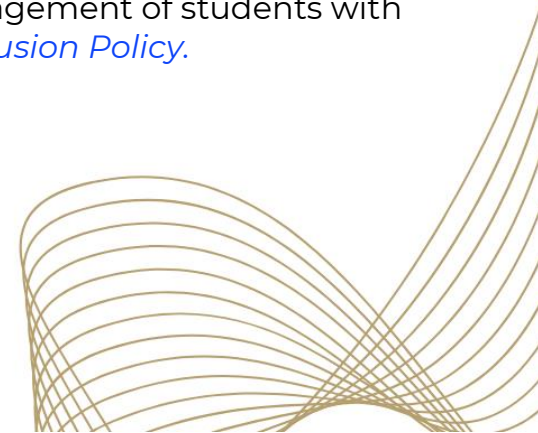


1.1 Development of Sustainability Strategy Future Leaders International Private School shall create a results-driven sustainability strategy that includes:

- A clear statement of our sustainability goals aligned with the UN Sustainable Development Goals and the policies of the Environmental Agency – Abu Dhabi (EAD) and other relevant entities (e.g., ADAFSA, DOE) including but not limited to:
 - The Abu Dhabi Quality Conformity Council (QCC) Standards for School Audits (QCC, n. d.)
 - *ADG 07 2017 Abu Dhabi Guideline for Green School – Sustainable Schools Initiative* (QCC, 2017).
 - e-Green Training the Trainers Course (EAD, n. d.).
- Policies that support the effective implementation of our sustainability strategy in line with ADEK wellbeing policies.
- Key initiatives, interventions, and action plans, ensuring inclusivity for students with additional learning needs, in line with [ADEK Inclusion Policy](#).
- Empowerment of students as agents of change through community service projects focused on sustainability.
- A commitment from school leadership to adhere to ISO 14000 standards.
- Mechanisms for measuring and monitoring the effectiveness of our sustainability strategy.
- Engagement with local community members and partners to support our sustainability initiatives.

1.2 Sustainability Governance A Sustainability Committee shall be established to oversee the implementation of our sustainability strategy. Responsibilities will include:

- Monitoring and evaluating the effectiveness of the schools's sustainability strategy and associated policies and initiatives.
- Conducting annual reviews to assess progress and make necessary adjustments.
- Ensuring compliance with ADEK wellbeing policies and incorporating feedback from the school community.
- Ensure that the sustainability strategy and associated [ADEK wellbeing policies](#) and initiatives consider the abilities, needs, and engagement of students with additional learning needs, in line with the [ADEK Inclusion Policy](#).





2. Integration of Sustainability and Environmental Wellbeing

2.1 **Curriculum Integration** Sustainability principles shall be embedded into the curriculum across all grades. This includes:

- Promoting environmental awareness and sustainable practices through educational programs and projects.
- Engaging students in practical learning experiences such as energy conservation, waste management, and gardening.

2.2 **Psychological Environment** Wellness spaces shall be established within the school to promote a calm and restorative environment, incorporating design strategies that enhance air quality and access to natural light, in line with the [ADEK student Mental Health Policy](#).

2.3 **Physical Space** Sustainability principles will guide the design and construction of school facilities, ensuring energy-efficient practices are followed, in line with the [ADEK Buildings and Facilities Policy](#).

2.4 **Reuse of Resources** We will promote the reuse of uniforms and learning materials through donation and resale programs. Schools shall also have a sustainable plan for lost and found items.

2.5 **Responsible Food Consumption** Sustainable eating practices will be encouraged, aligning with the [ADEK Healthy Eating and Food Safety Policy](#).

2.6 **Sustainable Procurement** We will adopt sustainable practices in our procurement processes to minimize environmental impact.

2.7 **Safe Sustainable Transportation** Awareness programs will encourage the school community to adopt sustainable transportation methods.

2.8 **Zero Waste Advocacy** We will promote “zero waste” initiatives at school events, encouraging the use of recyclable materials and mindful food procurement.

2.9 **Sustainable Technologies** A focus on digital resources over printed materials will be prioritized, along with the use of refurbished technology.



3. Awareness of Sustainability Strategy and Policies

3.1 **Awareness Promotion** We will actively promote our sustainability strategy to all stakeholders,; students, satff, parents and other relevant stakeholders, ensuring alignment with our broader wellbeing strategy, in line with [ADEK wellbeing Policy](#).

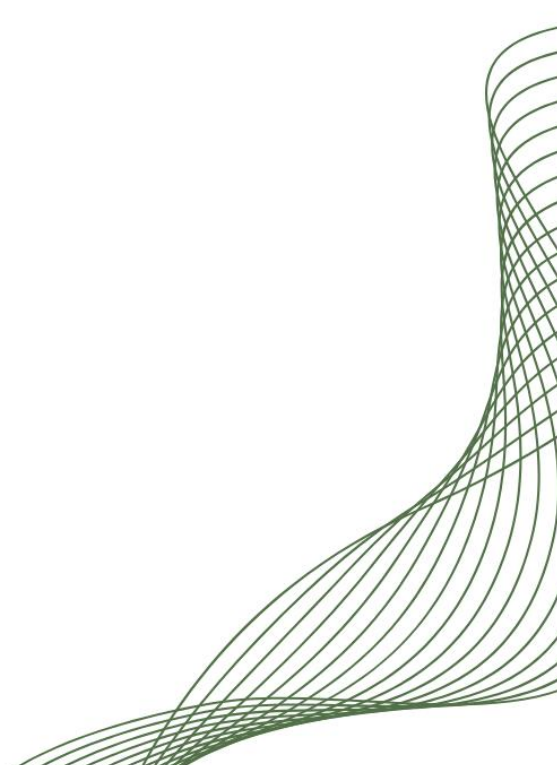
3.2 **Reward and Recognition** A recognition program will be established to celebrate contributions from students, staff, and the community towards our sustainability goals.

4. Monitoring and Evaluation

4.1 **Regular Monitoring** We will continuously evaluate the effectiveness of our sustainability strategy, incorporating [ISO 14000 standards for environmental performance](#).

4.2 **Community Feedback** Annual surveys will capture stakeholder knowledge and satisfaction regarding our sustainability efforts, guiding future improvements.

4.3 **Compliance with Evaluations** We will participate in any ADEK-mandated evaluations to assess our sustainability practices.



Role of Stakeholders



- **Teachers:** Integrate sustainability principles into their teaching, facilitate student engagement in sustainability initiatives, and provide mentorship for student-led projects.
- **Students:** Actively participate in sustainability initiatives, advocate for environmentally friendly practices, and engage in community service projects.
